ORDER GRANTING EXTENSION OF TIME TO FILE JOINT REPORT

THIS MATTER comes before the New Mexico Public Regulation Commission upon an unopposed motion (Motion) filed on June 13, 2012, by (Movants) New Mexico Gas Company, Inc. (NMGC) and the National Nuclear Security Administration (NNSA), seeking an extension of time to file a joint report detailing the discussions among NMGC, NNSA, and interested parties as required by the Commission's May 15, 2012 Initial Order. Having considered the Motion and being duly informed in the premises,

**THE COMMISSION FINDS AND CONCLUDES:**

1. On May 15, 2012, the Commission issued an Initial Order upon the Protest filed by the United States Department of Energy (DOE) on behalf of the National Nuclear Security Administration (NNSA) against New Mexico Gas Company's 2012 Integrated Resource Plan (IRP). The Order established a proceeding for the limited purpose of considering the issues regarding the IRP and the Protest. The Order also instructed interested parties, particularly NMGC and DOE, to meet and discuss the disputed issues and to file a joint report within 30 days of the date of the Order, said deadline being June 14, 2012.

2. According to the Motion, the Movants have held two meetings to discuss the disputed issues and all related matters, and they are close to an agreement that would resolve NNSA's Protest. However, in order to complete discussions and to file their joint report, the Movants have requested an extension of time through June 28, 2012.

3. The Motion should be granted.

**IT IS THEREFORE ORDERED:**

A. Movants' Unopposed Motion for Extension of Time is hereby **granted** through June 28, 2012.


B. A copy of this Order shall be served on all parties listed on the attached certificate of service via email, if the email address is known, and if not known, by regular mail.

C. This Order is effective immediately.

D. This Order is issued by the Chair of the Commission or by a single Commissioner in accordance with Rule 1.2.2.30(B) NMAC.
