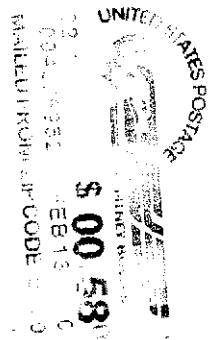

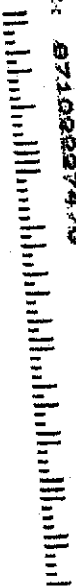

No NOTICE OF GARNISHMENT AND INSTRUCTIONS FOR OBJECTING TO THE ANSWER or CERTIFICATE OF SERVICE OF DOCUMENTS for Sandia Laboratory Federal Credit Union were included in Zavitz's certified mail 7005 1820 0006 5937 6669.

See attached affidavit.

Therefore, I was improperly served in the Sandia Laboratory Federal Credit Union action.

US attorney John Zavitz has a history of either not understanding or ignoring legal procedures.

In United States District Court - District of New Mexico 01cv00634 Zavitz failed to file entry of appearance before filing motion.

Zavitz's and the New Mexico US attorney's office appears to be demonstrating remarkably poor judgment peaceful in these matters not in the interests of the US or its citizens.

We feel peaceful settlement of these unfortunate matters is in the best interests.

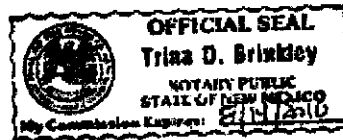
